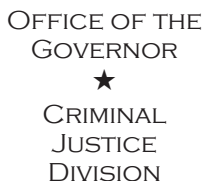

Opportunities for Equal Justice During 2010-2011

- **418** clients were helped with custody and visitation cases
- **601** clients were helped through the divorce process and **170** were helped out of a domestic violence situation
- **17** clients took advantage of the wills/estates program
- Of the **1,206** clients, almost **967** were women, **633** cases had domestic violence
- Over **\$77,000** in back/unpaid child support was gained on behalf of our clients
